 Dispatch of the Postal Ballot Notice along with the Explanatory Statement and the Postal Ballot Form to the Members of the Company was completed on 31st December, 2018. The said documents were sent by the Company in electronic mode to those Members who had registered their e-mail addresses



with the Company or with the Depositories and in physical mode to the other Members.

 Members whose names were recorded in the Register of Members of the Company or in the Register of Beneficial Owners maintained by the Depositories as on the cut-off date i.e. 21st December, 2018 were entitled to cast their votes by postal ballot or e-voting.

However, ITC Limited and Russell Credit Limited, being 'related party' within the meaning of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 abstained from voting on the Ordinary Resolution.

- Voting through postal ballot and e-voting commenced on 2nd January, 2019 and closed on 31st January, 2019.
