Textual Information()	<p>1) The voting rights with respect to 1,51,634 shares transferred to Investor Education and Protection Fund Authority are currently freezed as per Rule 6 of IEPF (Accounting, Audit, Transfer and Refund) Amendment Rules, 2017. 2) The number of shareholders as shown in this statement represent aggregate number of demat account and registered folios (in respect of shares held in dematerialised form and physical form, respectively). However, the total number of shareholders of Company as on March 31, 2025 is 13,495 but in the shareholding statement the number of shareholders are shown as 12,269 due to consolidation on PAN basis. 3) The aggregate promoter holding is 49,31,896. As disclosed in the previous quarters, Russell Credit Limited, one of the Promoters held 5 shares in the Company, however, as per their records, they did not hold any share. The said 5 shares were transferred to IEPF during the quarter ended 31st December, 2024. 4) Russell Investments Limited is an indirect associate company of ITC Limited. Accordingly, same has been categorised as a Promoter Group Company and not as Promoter Company. 5) 3914233 shares were transferred from ITC Limited (ITC) to ITC Hotels limited (ITCHL) pursuant to Scheme of Arrangement amongst ITC and ITCHL and their respective shareholders and creditors, sanctioned by the Honble National Company Law Tribunal, Kolkata bench vide order dated 4th October, 2024, effective from 1st January, 2025 (Scheme). ITCHL has been categorised as a Promoter Group Company basis the disclosure from ITCHL. 6) Under column B4(i), NRI includes total of both Repatriable basis (34,269 shares) and Non - Repatriable basis (30,735 shares). 7) Under Annexure B, First quarter is December 31, 2024, Second Quarter is September 30, 2024, Third Quarter is June 30, 2024, and Fourth Quarter is March 31, 2024. 8) Under Annexure B, Board approved limit is the Sectoral Limit. 9) Under Annexure B, limit utilised is NRI on a Repatriable Basis, as shared by the Registrar and Share Transfer Agent. The percentage holding of total Foreign Investment, as available in Foreign Investment Monitoring Report from NSDL is as follows: As on March 31, 2025 is 0.43 As on December 31, 2024 is 0.44 As on September 30, 2024 is 0.43.
